 Roof and sidewalls have been covered with

 steel roofing.
 Posts and beams have been removed. Center 14' of hayloft raised to 12'. 5x6 treated

 posts added on each side to support 8' of original hayloft floor for storage and support the raised center

 of hayloft floor.
 Horse stalls and stanchions have been removed. Some of the windows have been

 changed with 1 light residential windows and some of the original windows are covered with steel siding.


OTHER NOTES: 2x6 rough sawn cottonwood stud walls 14' high, with rough sawn cottonwood

sheathing and 1x2"x6" cedar lap siding. Wall sheathing is diagonal on the gable end walls. Rafters are

2x6 rough sawn cottonwood with rough sawn cottonwood sheathing, cedar shingles and covered with steel roofing.

*PHYSICAL NOTES: Large lean-to added to North side recently. Barn is in very good condition.




















History

This farm located in the NE ¼ of NE ¼ of Norway Township, Clay County was homesteaded by Ole B. Larson.

The 1894, 1901 and 1912 Clay County Atlas lists Amund Hanson as the owner.

The 1924 and 1937 Clay County Atlas lists August J. Kryger as the owner.

The 1948 and 1956 Clay County Atlas lists Magnus P. Jepson as the owner.

This barn was moved from the 80-acre farm just to the west of this farm. A capstan winch using horse power skidded the barn about ¹/₄ mile across the field in the winter. August J. Kruger may have built or had the original barn built as he owned the 80-acre farm to the west.
