
joists for the hayloft floor. The second floor is all hayloft with 13' – 6" sides and 28' 6" to peak. 6x6 posts and 6x6 beams support the center of rafters. 4x4 angle bracing help support posts and beams.

OTHER NOTES: 2x6 stud walls with 1x8 #106 drop siding. Rafters are 2x6's. Basement walls are native stone with sand and lime mortar. The North wall of the basement extends East about 25' for protection from the North wind. Windows are 8" x 10" six light in a 3 wide x 2 high sash. These windows are in the basement only, no windows in hayloft.
